Gordon Chang: Chinese Communist Party Is Preparing for War

The Chinese Communist Party (CCP) is preparing for a war, according to China analyst and author Gordon Chang.

Several recent developments in China's policies—particularly an amendment to China's National Defense Law—could signal that the regime is preparing for a full mobilization of its military, according to Chang.

"China's newly amended National Defense Law takes certain powers over military matters from the civilian State Council and gives them to the Communist Party's Central Military Commission, which controls the People's Liberation Army," Chang wrote in an email to The Epoch Times.

"That move centralizes military decisionmaking. Moreover, the amendment, which relates to war mobilization, signals that the regime is preparing the Chinese people for conflict."

In addition to centralizing the authority for military mobilization, Chang noted that the CCP is making efforts to effectively sanction-proof its political elite by forbidding certain officials from owning foreign real estate or shares in offshore companies.

"If Chinese officials and their family members do not own foreign assets, foreign countries cannot strip them of their holdings," Chang wrote.

"Shedding these assets, therefore, makes those individuals immune to one of today's most commonly imposed sanctions."

Through the centralization of authority over military mobilization and the shoring up of economic defenses against potential international sanctions, Chang believes that the CCP is preparing for the possibility of armed hostilities. The question remains, however, as to just where such a war could

Waging People's War

Following a month of unprecedented military exercises and economic retaliations, Taiwan is in the limelight.

There are numerous other flashpoints along China's periphery—any one of which could quickly escalate to outright conflicts—such as the mountainous Ladakh border region that China shares with India, disputes throughout the South China Sea with the Philippines and Vietnam, and disputes in the East China Sea with Japan.

Indeed, Chang believes that China's neighbors could be a potential target should the CCP believe the opportunity

"In the past few weeks, China's regime has put Taiwan in the spotlight, but the Chinese party-state is threatening most of its neighbors to its south and east," Chang wrote. "All neighbors there, large and small, are under threat."

"We do not know where Beijing will strike next. China's Communist Party does not act on grievances; it acts when and where it smells opportunity."

Beyond hostilities in pursuit of regional hegemony, Chang said there is another threat permeating the world—the CCP's ambition to leverage an international

evolved by Deng Xiaoping to promote longterm revolutionary communist struggle. According to Chang, the current CCP leadership is blending the doctrine of people's war with a global Chinese identity to weaponize the Chinese diaspora community and promote the CCP's interests.

"China's regime makes the 'blood' argument, that all Chinese are of the same blood and that all are therefore bound to support the Communist Party," Chang

"The Party has recently been making the case that it must unite the world—tianxia or 'All Under Heaven'—and that means uniting all Chinese, no matter where they live and no matter their citizenship."

Biden Unprepared for CCP Aggression

Though the CCP has been working on weaponizing the Chinese diaspora against the West for decades, Chang doesn't believe the United States is prepared for conflict with China. He said the Biden administration fails to comprehend the CCP as an adversary.

"President Biden gives the impression that he is oblivious to China's mobilization of Chinese society," Chang wrote. "He will not even call China an 'adversary,' and he certainly does not use the correct term, which is 'enemy."

To that end, Chang said he feared the administration is content to watch and wait as the CCP prepares for armed hostilities that could overwhelm the United States and its ability to defend itself.

"Biden must tell the American people what China is doing, tell the American people that they too must prepare for war, and tell the armed forces to get ready for battle," Chang wrote.

"Too often in the past, American presidents let enemies attack us first. The Chinese will not, with their first attack, give us the opportunity to rally ourselves."

While previous animosities in the Sino-U.S. relationship were effectively overcome through dialogue, Chang said that CCP leader Xi Jinping now maintains a military that is superior in every way to that of China 20 years ago, and that the regime is now, after years of preparation, prepared to go to war.

"Xi is making all-of-society preparations to engage in sustained conflict," Chang wrote. "China is now more ready for battle than it has been in centuries."





have been detailing the problems in the world economy in several of my previous posts. Now, it's time to explain

where it all began and why the situation in the global economy is so precarious. It all starts with China.

As I mentioned before, in late 2016, I was baffled. The world had just recovered from a "mini recession" to which there seemed to be no obvious reason. Suddenly, in 2015, the world economy just started to cave in without any clear indication from the eurozone and the United States that a recession would be coming. Then, in late 2016, the world economy "miraculously" recovered at breakneck speed. I wondered, what an earth was going on?

I started digging and stumbled onto the answer when I was analyzing the socalled leading indicators of the Organization for Economic Co-operation and Development (OECD).

I realized that China—not, for example, the United States—had driven the global economy since the global financial crisis of 2008 and 2009. This was visible from the leading indicators. I (we) estimated that, after 2008, wherever China's economy was heading, whether in an upturn or downturn, the economies of both the eurozone and the United States would follow, respectively, with a lag of around two to three months and a lag of around three to four months.

I dug deeper and found that China's economic cycle was totally driven by the leveraging/deleveraging cycle. This meant that whenever there was a push from Chinese leaders in Beijing to increase lending in the economy (leveraging), economic growth accelerated, and that when Beijing tried to diminish the growth of debt (deleveraging), economic growth decelerated. Thus, the global economic cycle had become dependent on the opaque decisions of China's leaders!

What happened in 2015 and 2016, then? In 2015, Chinese leaders tried to stabilize the Chinese economy by tightening the availability of credit (deleveraging), especially to the manufacturing sector. This led to a slump in the Chinese housing market, which had already weakened in 2014. Because real estate had been the backbone of the Chinese economy for the past two decades, the overall economy soured quickly. The Chinese stock market started to fall, and the global economy followed suit.

The rapid deterioration of the Chinese economy scared Beijing, and it enacted another round of massive debt stimucome from traditional sources. The reason why so few noticed in 2016 that Beijing was running yet another enormous stimulus program was because it was orchestrated through the so-called shadow-banking sector.

Shadow banking is a term used to describe part of the financial sector that operates outside of, or is only loosely linked to, the traditional system of deposit-tak-

ing institutions. It provides credit intermediation through different institutions, instruments, and markets. Effectively, it's a deposit-like banking system for firms and institutional investors, but because it doesn't accept deposits in their traditional form from consumers and corporations, it mostly falls outside the banking supervision, regulative framework, and lending statistics.

The collapse of the shadow-banking sector was the reason behind the financial crisis from 2007 to 2009 and the global recession that followed. However, while the estimated size of the shadowbanking sector was around 140 percent of gross domestic product (GDP) in the United States in 2006, it was more than 330 percent of GDP in China in 2016!

Alas, China "saved" the world economy from succumbing to a recession in 2016 by issuing an unprecedented credit spree running through the shadow-banking sector.

It would be truly interesting to know what the current size of the shadowbanking sector is in China, but I have been unable to find the current estimates of it from the reports of the People's Bank of China (PBC). This may be due to the fact that PBC doesn't publish its estimates anymore or that it publishes them only in Mandarin, or that I have simply missed them regardless of my extensive

Either way, it doesn't alter the overall conclusion we made some five years ago: China is an economic giant with "debt clay feet." Its economy has been kept standing only by relentless and utterly unsustainable debt stimulus since 2007. Alas, China's economy is heading into a

nearly inevitable collapse. It's obvious that the economic collapse of China would bring serious social unrest and even lead to an outright uprising. I consider this as the primary reason for the tightening grip of the China Communist Party on Chinese citizens. It wants to make sure that when the economy

implodes, it has the means to quell the

massive discontent it will give rise to. For the world economy, this isn't good news, as we have effectively made ourselves into an economic hostage of two totalitarian regimes: Russia and China. It should be noted that this has been our own doing. Our politicians haven't listened to the voices warning us of the increasing economic dependence on China and Russia.

Now, we are learning that lesson the hard way. Let's just hope this time the warning gets through to those who should listen.

US 'Heavily Dependent' on China for Rare Earth Elements: Rep. Stauber

The U.S. dependency on China for rare earth elements is a security risk and is being exacerbated by the Biden administration's forced transition to so-called green technologies, according to lawmakers and experts.

The Biden administration's top-down push toward renewable energy requires an enormous growth in the mining of rare earth elements. Currently, the United States relies on the mining and processing powers of China, which has far worse environmental regulations, to achieve many

"We're heavily dependent on foreign adversarial nations," Rep. Pete Stauber (R-Minn.) said during an Aug. 22 interview with NTD, an affiliate media outlet of The Epoch Times. "If today, the communist country of China stopped selling us their critical and rare earth minerals, we would be in deep trouble from our national defense to our manufacturing

across the globe." Rare earth elements are a number of el-

ements with unique characteristics that have made them vital to new technologies. Critical minerals are those rare earth elements that have no substitute, are limited in supply, or are economically vital.

Stauber's comments come just weeks after U.S. Treasury Secretary Janet Yellen said the United States would try to end its "undue dependence" on rare earths, which it requires to manufacture various technologies, from solar panels to electric vehicle batteries to smartphones.

"It's unfortunate that this administration has put their dependency for both critical minerals and rare earth minerals in the hands of the communist country of China," Stauber said. "It's simply unacceptable when we have the critical minerals and a few of the rare earths right here in the United States. This administration just won't let us mine."

According to Stauber, the Biden administration lacks the political will to simply mine the needed elements domestically. For example, nickel, copper, and cobalt are all present at extant mining operations in Minnesota. However, instead of allowing U.S. companies to mine these, the administration is pursuing a policy of "friendshoring," wherein it merely transfers supply chains for offshored goods from China to more friendly nations, such as South Korea.

"We have the best environmental standards, best labor standards, and the opportunity to secure our supply chain dependency and put the destiny of our great nation in the palm of our own hands," Stauber said.

"It doesn't have to be this way. We must have an administration that understands the importance of securing our critical needed elements domestically. For minerals and our rare earth minerals. We have to return this country, the United States of America, to mining and mineral dominance. And we can do that, if we have operations in Minnesota. However, the political will."

China Weaponizing Rare Earths

policy adviser at the Heartland Institute, said the fear of China weaponizing its growing power of rare and critical elements isn't without precedent.

"In 2010, Japan and China actually had a conflict over rare earths," Bridges told NTD. "China responded by cutting off Japan's access to the rare earths, which really had an impact on Japan's manufacturing capabilities.

"So it is not outside of the scope of the imagination to believe that in a time of warfare, indeed, China would leverage this kind of power."

China is the largest global player in many critical minerals, for which demand is currently skyrocketing because of technological development. To that

ily Tang Williams is a survivor of communist China's Cultural Revolution and is now a congressional candidate for New Hampshire's 2nd District. Williams calls America a promised land and said she chose to emigrate to the United States for freedom, but she's seeing a disturbing trend toward totalitarian Marxist ideology. Williams warns that she sees the push for "equity" or social justice as a guise for socialist wealth redistribution.

"Now I notice socialist policies, and today, everybody is talking about 'equity, equity.' How can you have equity—which is equal outcome, which I heard in China before without the government using force to redistribute wealth?" Williams said during an Aug. 18 interview for EpochTV's "American Thought Leaders" program.

In 1988, Williams immigrated to the United States determined to succeed because she did want to return to communist China. Since that time, she has lived the American dream with a happy marriage, three children, and a good business, she said. Williams never had plans to get into

But because she sees the disturbing trend toward communism, she said she felt compelled to join the government to stop the rights.

Wrong Type of Education

Williams questions why every institution from universities and public schools to the federal government, private corporations, and the U.S. military—is teaching equity.

She also sees Black Lives Matter and Antifa using violent Marxist tactics in the name of social justice. She sees schools pushing identity politics and division instead of teaching core subjects and accurate American and world history.

"And our kids don't know," she said. "Maybe that's why they want socialist policy. They want ... free college and free health care and free child care and everything free, because they're entitled to it."

She said shutting down schools and churches and toppling statues of American leaders all resembles communist ideology, and the same things happened during China's Cultural Revolution. In addition, the All religions were demonized. We could not call ourselves Buddhist or Christian nothing. You've got to be the believer of Mao and communism.

Williams has seen many other aspects of totalitarianism during the last two years of lockdowns and mandates.

"I see this rise of authoritarianism. We have politicians who want to be our tyrants. They want to shut you down. They the name of [the] pandemic, and then mandate—mandate the vaccine, mask. And if you don't comply, you can lose your job," she said.

Williams warns that communism is coming to America if the country continues down this road of dividing people and pitting them against each other.

"I see the writing on the wall. I see this trend," she said. "We are using identity politics to divide citizens and get our citizens to fight each other instead of [being] united with each other to solve our country's problems."

"Why are Western democratic countries taking Communist Party's tactics and the shutdown methods from their playbooks?" said Williams.

She objects to people being given preferential treatment because of their skin want to force your business [to] close in color, instead of merit. Williams cited the fact that Ivy League universities are filling quotas for black students at the expense of Asian students, who work hard and earn their place at these schools.

The State Before Family and Tradition

William also disapproves of the transgender ideology that children are being indoctrinated with in schools, and in many cases without parental knowledge or consent. The state is overriding the rights of the parents, as in the case of some states that are introducing legislation to bypass parental consent for gender changes at the age of 13.

She said she is reminded of China's Cultural Revolution, where everyone was constantly indoctrinated with communist ideology in all public forums. From media to schools, they all espoused Mao's ideology of the oppressor and oppressed having to struggle against each other.

Her family was labeled the "red" class, or one of the oppressed groups, while land owners and intellectuals were labeled the "black" classes.

"Under oppressor, there are five black classes. Under oppressed, there are five red classes. I was red. I did not have to go to struggle sessions, but other people were [labeled] black classes. They have to go to struggle sessions [and] be publicly shamed to denounce their families, their ancestors," Williams said.

Mao targeted Chinese traditional culture by destroying the "four olds," which included: Old Ideas, Old Culture, Old Customs, and Old Habits.

"And all religions were demonized. We could not call ourselves Buddhist or Christian—nothing. You've got to be the believer of Mao and communism."

Humans Naturally Seek Liberty

After Mao's death, the new communist leadership allowed the Chinese people to keep some of what they harvested for themselves, in a sense allowing a bit of landownership, so people began to produce more food compared to the Cultural Revolution period, said Williams.

Because of this economic improvement, the Chinese Communist Party (CCP) took credit for lifting over 600 million Chinese out of poverty, but Williams completely disagrees and credits free market principles, individual hard work, and desire for prosperity for the improved economic

"I don't buy into their propaganda at all. I think that human beings [have a] natural desire for freedom, for prosperity. They know how to do it, if you just leave people alone."

Indoctrination

Because of the complete state control over the information people got, from the media to schools, people in China really believed the "black class" should be destroyed, or at

"I believed then, we need to eliminate the people and the enemies of the state,"

She said another tactic Marxists use is to exploit peoples' jealousy of the rich. Mao promised land to peasants but he never gave them land. They only worked on stateowned land to make the Communist Party rich, said Williams.

Fleming described TikTok as an "espionage application" and said it's being used to systematically harvest the personal information of Americans, particularly the

"People need to understand that TikTok is a weaponized military application in the

hands of our middle schoolers, our kids, our high school kids, and our young adults," Fleming said.

He added that the app is likely being used as part of the CCP's strategy of "hybrid war," in which the regime seeks to achieve military objectives through nonmilitary means.

To that end, he said, the app is being used to steal intellectual property, spread pro-CCP propaganda, and obtain information on Americans to be later used for blackmail.

As such, he said, Americans need to better understand the danger the app poses, and how it's being used to promote China's communist policies.

"You absolutely must believe and consider that anything coming out of China is controlled by the Chinese Communist Party," Fleming said. "That's what we as Americans, and people in the West, really get confused.

"We think that China is just like the United States, with the same type of management, government, values, and so on. It's not. Everything in China, whether it's a company, whether it's an app, is completely controlled by the Chinese Communist Party."

Fleming said that the United States wouldn't be able to continue to tolerate the proliferation of the app and also maintain a free society, and that the theft of data from millions of Americans, including children, was a form of hostile foreign influence over the nation.

"We really need laws and policies to say foreign influence should never be allowed in the United States, and we need to shut it down immediately," Fleming said. "Understand TikTok is not your friend.

If you love your children, if you love your family, get the TikTok app off your phone, your tablet, your computer.

The CCP Is Destroying China's Future

A decade of abuse has left Chinese society, people, and the environment desolate

Social and environmental costs have long taken a back seat to the Chinese leadership's drive for national economic and technological development. But now the leader of China is seeking a third term. Has he earned it?

It depends on the metric. A quick recap for context is helpful.

Remember the Beijing Model?

It was only 10 years ago that the world was all abuzz about the "China miracle." The "Beijing model" of national development was certain to replace the liberal free trade model of the West. For quite a while, it seemed that it would. To the world's great detriment, that may still be

Recall that as China's economy grew by double digits for most of three decades, it saw amazing growth in both manufacturing and sophisticated technology sectors. Much of China's technological, biomedical, and robotics capabilities now rival those of Europe, Japan, and the United States.

China faces a number of deep-seated and widespread environmental and human crises that are rapidly destabilizing the country.

The Belt and Road Strategy

China's ambitious Belt and Road Initiative exported the Beijing model's promises to much of the world. But after the deals with Beijing were done with weaker developing nations, those nations found themselves in bottomless debt traps that effectively transferred their national wealth to their Beijing overlords.

That's fine and dandy, as far as Beijing is concerned. Chinese-owned ports, railways, factories, and farms are now on every continent—many in quite strategic locations. China's power and influence are now felt around the world.

Penetrating the West

Moreover, the Chinese Communist Party (CCP) spent decades diligently penetrating the West's political, cultural, media, academic, and financial establishments. Its efforts have paid off. Chinese influence is in our highest and most prestigious universities, news agencies,

entertainment media, and centers of technological innovation.

As a result, China's industrial sectors continue to reap those benefits today, leading the world in artificial intelligence, robotics, bioengineering, and a

plethora of other high-tech verticals. Finally, China's military power is now, in key respects, a top-tier fighting force. Its blue water navy now rivals the U.S. Navy, with the ability to project power throughout the Asia Pacific and beyond. Plus, Beijing's hypersonic missile technology supposedly leads the world, for which the United States has no effective defenses.

In light of such multiple successes, one might say about all of this, "What's not to

Destroying the Economy

There's plenty, actually. Technological and even geopolitical successes are important, but they're transitory and far less important than the actual state of Chinese society and of the land and resources in the country itself.

China faces a number of deep-seated and widespread environmental and human crises that are rapidly destabilizing

As the absolute authority over every aspect of Chinese life, the Party leadership bears full responsibility for the country's policy failures, and examples are plentiful.

The "zero-COVID" policy has perhaps irreversibly stifled manufacturers' activity. By locking down major financial and manufacturing hubs such as Shanghai and Shenzhen, tens of millions were suddenly out of work for months on end. This not only impacted China's productivity, but disrupted supply chains, prompting foreign companies to move their operations out of China.

The extended lockdowns have also increased the Party's control over the people. This may seem to be a victory for the CCP, but, ultimately, it's damaging the human spirit in China, which is already showing signs of serious long-term demographic and economic impacts.

Destroying the People

The Party's short-sighted one-child policy, which was finally changed in 2016, has created huge social crises that are only now beginning to manifest themselves, with China now facing a dramatic baby shortage. Births are at record lows, as young Chinese aren't in a hurry to get married or have children. Even though Beijing has recently instituted a threechild policy, the rapidly falling fertility rate and declining working-age popula-

tion trends remain unchanged. At the other end of the age spectrum, for the generation nearing age 60, there isn't enough money to fund their government pensions. The system faces a shortthe next five years. As a result, the Party is delaying the retirement age gradually over the next three years. But that's creating another problem with younger

Yields have fallen dramatically and will only worsen with the country's increasing reliance on coal and fossil fuels. This will only drive Beijing's reliance on foreign food sources as it despoils its homeland upon which 1.4 billion people live.

Of course, this has been just a surfacelevel discussion of the lesser-known costs of the CCP's ravaging of China and its people. However, it seems difficult to overestimate the societal impacts that are already beginning to emerge.

In the drive for global supremacy, the current leadership is systematically destroying all three, resulting in a desperate people, a cynical culture, and lands and waters poisoned and desolate.

Presumably, the leadership will be reelected to continue on that path.

To appreciate how China's technological authoritarianism threatens the world, consider solar energy. What's seen as a clean, modern and relatively high-tech alternative to fossil fuels has become another example of the Chinese Communist Party's (CCP) strong-arm approach to bullying other countries and dominating an industry. Worse yet, many American investors are willfully blind to Beijing's monopolistic tactics and use of slave labor, prizing their "green" portfolios over U.S. energy security and human rights.

Here's the good news: economies of scale have enabled cost reductions that many experts predict will lead to solar energy comprising 60 percent of the world's energy needs by 2050. This will help reduce greenhouse gas emissions and go a long way to address climate

But here's the bad news: the inconvenient truth is that the manufacturing of solar cells is an energy—and labor-intensive process. Large Chinese companies—several of which are listed on U.S. stock exchanges—dominate the entire solar supply chain controlling between 80 percent to 90 percent of nearly every

Since 2017, these firms have been heavily incentivized by the CCP to locate their facilities in the Xinjiang region of China, which is not only home to the world's two biggest coal-fired power plants but also ground zero of the CCP's genocide of the Uyghurs. A major element of that genocide is the widespread use of forced labor, in which nearly every major Chinese solar firm has been implicated.

Even as Chinese manufacturers have off-shored panel assembly and other later stages of the supply chain across Southeast Asia to avoid U.S. sanctions, China's domination of the production of polysilicon—the base of the global photovoltaic (PV) solar supply chain—and the centralization of polysilicon production in Xinjiang means that the problem of forced labor remains endemic in PV

Confronting a Bully

As we have witnessed recently at the gas pump, energy security is national security. Unless drastic action is taken, we will find ourselves at China's mercy for our energy needs, just as Germany found itself at Russia's.

Beijing has a history of trying to bully its way to the top of industries by deploy ing the "Power Principle" of duplicity, intimidation, retaliation, domestic oppression, coercive economic practices, and grave human rights abuses. Fortunately, as recent history of 5G wireless competition demonstrates, the CCP has a fatal weakness: no one trusts it.

To counter authoritarian predators, like the CCP, our team at the State Department developed the "Trust Doctrine" rooted in democratic values, such as respect for the rule of law, human rights, labor practices, and the health of our planet. The deployment of the "Trust Doctrine" turned the tables on the CCP by promoting exclusive collaboration with entities that can be trusted to play

In less than a year, the trust-based Clean Network Alliance of Democracies succeeded in bringing together 60 Clean Countries representing two-thirds of the world's GDP, 200 Clean Telcos, and dozens of industry-leading Clean Companies committed to only using trusted 5G vendors. Former Defense Secretary Leon Panetta observed that this trust-based alliance created an enduring, replicable model for all areas of techno-economic competition.

A Model for Diplomatic and Economic Cooperation

The same trust-based model that helped thwart China's wireless hegemony can loosen its grip on global solar production. Just as like-minded countries and companies rallied to exclude malign actors from advanced wireless networks, so can the "Trust Doctrine" behind the Clean Network be applied to our ESG (environmental, social, and governance)

For example, we should exclude Chinese-domiciled firms from ESGdesignated funds, urge the Securities and Exchange Commission to define a company's domicile in China as a "material risk," and rationalize our existing sanctions regimes to ensure that companies that are implicated in human rights abuses or national security threats lose unfettered access to U.S. capital markets.

The world's democracies, led by the United States, have the moral legitimacy and economic power to stop a bully in its tracks. And now, we have a model to do it. Alliances built around shared values—fundamental to what is now known as "Tech Diplomacy"—are vital to both our economic self-interest and to the moral leadership we must summon toward a freer and fairer world.
